Your application must include **4 photos each** or a public social media link of your art/craft if this is your first year applying. Applications received without photographs or public social media links will not be accepted. You will be notified of our acceptance of your application within 1-3 weeks after receipt. Applications received after September 1, 2023, will incur an additional \$15.00 booth fee, and will be accepted only if booth space is available, and will not be listed in the festival brochure. Pre-payment of booth fee is required with your application and is non-refundable upon acceptance. The Festival is "Rain or Shine" no packing up before 2:00 pm. **NO WHEELED** vendor trailers are permitted in the arts/crafts, demonstration, historically appropriate, or non-profit informational areas with the exception of load in and load out. **ALL VENDORS** must follow the OWSF Guidelines and Policies. Applications will not be accepted after September 13, 2023. **Kids booths are only eligible to individuals 18 and younger.**

**An adult responsible for the child MUST be present at the booth at all times. Booths will be permitted to stay up until the end of Saturday's festival at 5pm.**
